Introductions

A special welcome was extended to Julie Gabelein from the Arthritis Foundation. This was her first HAP meeting.

2009 Work Plan

Karen Lewis reviewed the draft work plan. For a copy of the draft or to send comments, contact karenl@chef.org.

The Falls Prevention Committee has decided to focus their efforts on promoting physical activity

through (1) the Active Options searchable database and (2) through community outreach in 4 King County neighborhoods (TBD). Alan Abe is currently contacting community and senior centers in targeted areas to gauge interest. Once sites are selected, key stake holders from each community will be invited to help develop community-specific falls prevention implementation plans. We are working with Allen Cheadle from the UW-HPRC to develop the evaluation component of the campaign.

Budget

Karen Lewis gave a budget report. There were no significant changes in the budget from the January meeting.

Seattle Pacific University Nursing Practicum Update

Carol Redfield, nursing supervisor, was able to attend the meeting and get a better sense of the organizations that comprise HAP. Karen Lewis shared that the project has been approved and the 4-5 students will begin their work April 1st for a 12-week period. The primary goal of their project is to conduct outreach to physical activity providers in King County to have them either update their information in Active Options or complete a survey to have their information published in the searchable database.

VISTA Update

Robin Knudson shared that she, Sheryl Schwartz, and Karen Lewis interviewed two excellent VISTA applicants and offered the job to their first choice - and she accepted! Kathleen Ryan will join the HAP team in mid-April and she will work for HAP full-time for 12 months. Kathleen will be located at HPRC and Sheryl will be her primary supervisor. We are thrilled that she accepted the position and know that she will add a tremendous amount of skill, organization and leadership to our falls prevention efforts.

EMS Falls Campaign Update

Alan Abe shared that this week he will be interviewing applicants for a half-time marketing position to seek additional corporate, foundation, and grant funding to assist with the falls prevention campaign. He hopes to have this person in place sometime in March.

Discussion: What's Behind Repeated Falls?

John Deagen led a discussion on the topic of repeated falls in older adults and what underlying issues could be causing these falls. He encouraged front line workers to dig deeper to uncover if there is a history of domestic violence, self or caregiver neglect, or isolation that may be playing a role in falls. We also discussed the impact of the economic recession on nursing facilities and other organizations that serve older adults.
